

# California

The California Pink Line eHub serves Marshall Square and the greater Little Village community through various transformation initiatives. With the help of Latinos Progresando and the OPEN Center for the Arts, the eHub is working to implement walkability and streetscaping improvements, create artistic pathways and green spaces to connect Douglas Park to the Pink Line station, and promote health-focused programs and businesses. In addition, work focuses on creating a new community center in a former Chicago Public Library space that will be geared towards immigration, legal, and healthcare services for residents.
