ETOD happens when City departments and communities work together.

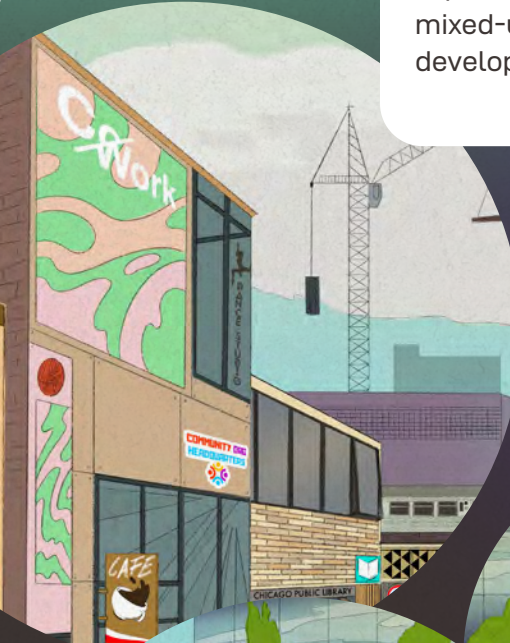
It's urban planning done with, not to, community members. It's capital investments that bring jobs, and ETOD is climate-resilient development.

Equitable TOD (ETOD) is community-driven development that enables more people from all neighborhoods and backgrounds to experience the benefits of dense, mixed-use, pedestrian-oriented development near transit hubs.



It's locally owned businesses that build wealth for local community members. ETOD is easy access to healthy food and health resources.

It's vibrant spaces where artists work in ways that reflects the community.



It's affordable housing near public transit that reduce household expenses. ETOD is options for getting around, including public transit, bus and rail.



It's streets, sidewalks and paths that encourage exploration, promote health and feel safe.

Elevated Chicago looks at ETOD through the lenses of racial equity, health, climate resilience, and arts and culture

Elevated Chicago is dedicated to creating equitable transit-oriented development that benefits everyone, especially **those impacted by inequities** in the built environment across the City of Chicago.

As a dynamic multi-sector collective and convener of people, Elevated Chicago promotes equitable development of public spaces, buildings, and vacant land around the city's transit hubs. We seek to increase resident engagement and remove barriers through advocacy, direct investments, arts and culture, and using creativity as a bridge to connect and amplify the local power in neighborhoods.

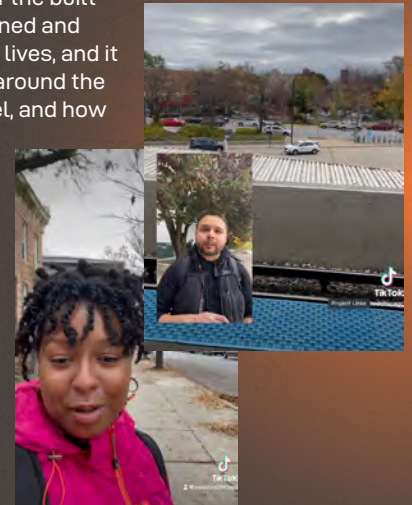
By 2027, we envision making meaningful progress to our vision of a Chicago where every community is vibrant and inclusive and connected to frequent, safe and accessible transit. We envision improved infrastructure across the city, ribbon cuttings by community leaders and emerging developers, the passage of equitable policies and investments, and new processes that represent and uplift all voices inclusively.

What is “built environment?”

Built environment is the human-made design and creation of our surroundings that impact our everyday life.

Think about your neighborhood: the streets you walk on, the stores you visit, and even the playgrounds and parks—all of these are parts of the built environment. It's designed and built to help us live our lives, and it affects how we move around the world, how safe we feel, and how our communities look, function, and interact with one another.

Our “Can You Walk There?” social media series navigates and investigates the built environment.



people — place — process

We support neighborhood residents, business owners, aspiring developers and artists, who live and work within ½ - mile radius of transit hubs—especially in neighborhoods impacted by disinvestment and displacement.

We adapt our internal processes to create conditions for our members to thrive as individuals, organizations, and as part of the collective.

We transform the built environment in the ½ - mile radius around public transit (e.g., Chicago Transit Authority, Metra, Pace).

We build partnerships with regional and national movements to address the challenges faced by disinvested, segregated, and gentrifying neighborhoods and improve quality of life for their residents.

We push public, private, and civic organizations to create processes that are more accountable, transparent, and inclusive.

Internally, we will redesign transparent and inclusive processes to strengthen our collective tissue and ensure we are building collective power for driving transformative change.

our purpose



Uniting ETOD Champions We will continue amplifying residents' power by focusing on increasing engagement in community and decision-making tables. We will foster a sense of ownership and unite residents and other stakeholders who see the benefits of ETOD to drive change throughout our neighborhoods.

ETOD Education Boost We will share information and tools about urban planning and development and continue providing technical assistance and support to residents, emerging developers, and other leaders to enhance their ability to influence local projects and policy decisions effectively.

Amplifying Community Culture We will partner with residents to ensure they and their communities have the tools they need to participate in decision-making processes and the built environment through a cultural amplification and protection lens. We will uplift the vibrancy and local culture in neighborhoods by promoting inclusivity, connection and community pride and increasing economic opportunities for local artists.

Smooth Transitions, Strong Continuity We will ensure the continuity of our collaborative efforts by setting a clear and transparent onboarding and off-boarding process. We will foster seamless transitions for new and departing members, enhancing continuity and memory, while also continuing to nurture our members' bonds, relationships, and trust.

Teamwork Remix We will continuously assess the size and structure of membership across our governance body to ensure they are appropriately staffed to meet our goals. We will foster a supportive and connected environment where members do not feel isolated. We will also ensure our teams reflect the diversity of the people we serve to enhance our ability to engage and collaborate effectively

Intentional Partnerships for Collective Power We will increase collaboration with organizations and people aligned with our vision to advocate for equitable development, policy and research. Utilizing our platform and resources, we aim to amplify diverse voices and unify our efforts towards advancing ETOD.

Bricks and Mortar Investments We will continue to invest capital and provide technical assistance/support to brick-and-mortar projects that lead to a more equitable built environment, and that directly address racial equity, public health, climate resilience, and cultural vitality.

Cultural Place Making, Place Keeping We will continue to invest in campaigns and activations that transform overlooked spaces (e.g. empty lots, underpasses) into cultural spaces and positive programming that uplift the neighborhood's culture and values.

Walkability and Mobility Justice We will continue to promote efforts and improvements that increase pedestrian safety and accessibility for all, with holistic enhancements from infrastructure to beautification, so that residents have an abundance of options for connecting to assets, amenities, opportunity and each other.

Natural and Climate Resilient Places We will continue to partner with local organizations to create and maintain green spaces and projects that address climate change and promote sustainable healthy climate-resilient spaces.

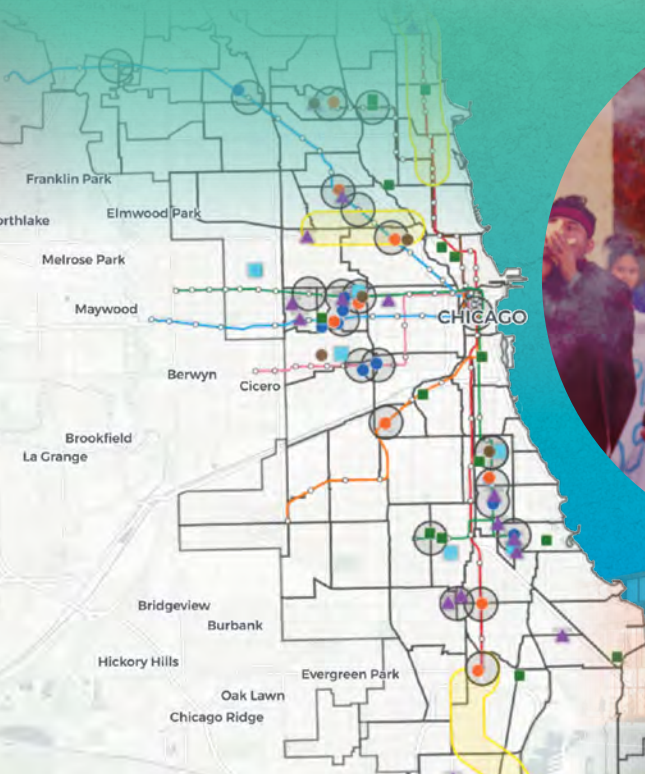

Equitable Policy Leaders We will co-lead the refinement and implementation of Chicago's ETOD Policy Plan and Connected Communities Ordinance to ensure accountability and maximize community impact by working with city officials, emerging and established developers, policy experts, and neighborhood leaders

Advocate, Amplify, and Advance We will continue advocating for increased public, private, and philanthropic funding and policies that support equitable development near transit hubs. We will collaborate with regional and national partners to advance a federal ETOD policy agenda, promoting best practices and securing resources for local initiatives.

Principled Community Engagement We will continue to amplify community power and foster deeper participation in decision-making processes. We will bring our community engagement principles to life through the diffusion of tools and processes (e.g., In.Field Kit) that facilitate delightful community engagement and improve information sharing.

The Connected Communities Ordinance one-pager; bringing community and government together to advance ETOD through the ETOD Working Group; Steering Committee co-chairs Christian Diaz and Lesle' Honore' amplifying partners and community voice at decision-making tables; The Elevated Chicago Rules of Engagement During Meetings grounds us in our values and how we work.

Governance Refresh We will establish clearer and more transparent decision-making processes, including guidelines for activities, votes, succession planning, and expected commitment from members. We will decide the best legal structure to achieve our mission. We will deepen our relationships through iteration, cross-collaboration, navigating lines of difference, and improving communication across our many members to foster a unified implementation of our work plan.

Set, Follow, and Reflect on Our Chosen Path We will regularly evaluate and refine our activities to ensure they align with our purpose and values. We will set clear goals to work towards and remain responsive and accountable to residents' needs.

Coalition Cohesion "Everyone's projects are everyone's projects!" Our work is a group effort, and one that is led by the individuals in our coalition—from policy advocacy to brick-and-mortar openings. Our commitment to advance our work also extends to members' work and the shared pipeline of projects we create. We will ensure the coalition is building power and adaptively moving towards our goals by keeping all members informed of moving pieces and how they add up to the whole.

Elevated started as the Chicago collaborative table of SPARCC*, a national initiative with a 10-year theory of change. This workplan is aimed to set our intentions for the next 3 years, as we arrive to the final years of SPARCC's theory of change, reflecting on Elevated's path thus far, and acknowledging our successes and our gaps to continue working towards equitable development.

***What was SPARCC?** The Strong, Prosperous and Resilient Communities Challenge (SPARCC) was a multiyear initiative investing in and amplifying local efforts in six regions (Atlanta, Chicago, Denver, Los Angeles, Memphis, San Francisco Bay Area) to ensure that public investments in the built environment reduce racial disparities, build a culture of health, and respond to the climate crisis.
